## **Job Description**

The project aim is to study the relationship between the fruit quality of apples intended for food processing and the presence of Alternaria mycotoxins. The research is conducted in collaboration with a local company working in the field of fruit processing. In particular the candidate areas of responsibility are as follows:

- Development of an analytical method based on LC-MS for the quantification of mycotoxins in food samples
- Method validation according to ISO 17025
- Managing samples collection in collaboration with the project partner and the subsequent analysis
- Elaboration of the data obtained and their presentation (conference and/or scientific paper)

#### Requirements

- completed university studies of at least four years attested by a diploma in chemistry, pharmacy, biotechnology, natural science or similar.
- maximum age 40 years (born after 01/01/1984)
- PhD title (study completed within April 30<sup>th</sup>, 2025)
- knowledge of Italian or German (will be evaluated during the interview)
