Job Description

The 'Alpruning' project is developing an innovative solution for the professional pruning of apples using artificial intelligence. The aim is to use smartphones and smart glasses to improve the quality and efficiency of pruning, even when unskilled labour is involved. This technology is intended to reduce the amount of labour required and combat the shortage of skilled workers in agriculture. The project partnership consists of 5 partners, of which the Laimburg Research Centre is one of the three scientific partners. The main tasks consist of:

- supporting the development and implementation of new methods for the recognition of long, linear structures and 3D modelling of plants.
- carrying out field trials and tests to evaluate and improve Alpruning technology.
- collaboration in the development of practical prototypes.
- collaboration with research institutions and technical colleges to communicate the technology.

Requirements

- completed university studies of at least four years attested by a diploma in agriculture, natural science or similar. The position is also open to those who hold a bachelor's degree in the aforementioned disciplines; however, if hired, they will be offered a lower salary position
- knowledge of Italian or German (will be evaluated during the interview)

Desired additional competences constituting evaluation criteria:

- knowledge in pruning of permanent crops
- experience in the field of apple production
- PhD, Post-Doc experience or relevant work experience
- good knowledge of spoken and written English can be evaluated during the interview
- good knowledge of the second language (Italian or German) can be evaluated during the interview
- good organizational and communication skills
- availability to start preferably within September 2024
- candidates should be highly motivated, able to work independently and possess good team-working skills
